Lambriht of Redgrave & Galiena, his wife, for homage
etc. & 15s. sterling a piece of arable land in the
parish of Burgate in a field called Menehaye(?) contain^{ing}
 $\frac{1}{2}$ acres, lying between the land of Richard de Boiland
& a fee of the abbot of St. Edmund & abutting on the land
of the said Richard Lambriht & on a fee of the said abbot,
for annual rent of $3\frac{1}{4}$ d. paying on the feast of St. Michael
 $1\frac{1}{2}$ d. & at Easter $1\frac{3}{4}$ d. Property not to be granted to
a house of religion or Jews. Witnesses: Peter de Burgate,
Hugh son of John(?Fitzjohn), Adam Cissor, Godman Unwine,
Roger de Mikelwode, Hugh de Wode, Stephen Leche, & others.
