The above incomes are the top limit at the time of acceptance. After acceptance, incomes may be increased to five times the rent.

There are no minimum income levels other than that the family must be able to pay the rent. Incomes from any source are considered.

Be citizens of the United States



Be residents of Chicago



Have children  
(except for aged couples)



Have an income below the maximum



Be living in substandard housing

It is extremely overcrowded

# THE CHICAGO HOUSING AUTHORITY

is a municipal corporation established under the Housing Authorities Act of the State of Illinois. Under the terms of this Act it has the power and the duty to engage in low rent and slum clearance projects.

The IDA B. WELLS HOMES are operated by the Chicago Housing Authority. They were constructed with funds loaned by the United States Government. The Chicago Housing Authority also operates the Julia C. Lathrop, Jane Addams and Trumbull Park projects.

Both the State and Federal laws require that these dwellings may be rented only to families of very low income, who otherwise could not afford good housing.
