Scope Note

The collection contains material compiled by Dr. L. Vernon Briggs, Director of the Massachusetts Department for Mental Hygiene, regarding the criminal trials and mental competence of the three convicted murderers who were the subject of his book The Manner of Man that Kills: Spencer-Czolgosz-Richeson (1921). Volume I contains affidavits, clippings, correspondence and other documents regarding Leon Czolgosz, assassin of President William McKinley, and Clarence Richeson, executed for the 1911 murder of Avis Willard Linnell. Volume II documents Briggs' assessment of Bertram C. Spencer, convicted of killing Martha B. Blackstone in Springfield, Massachusetts. The collection also contains photographs and glass plate negative images of Richeson, two letters from Emma Goldman about her connections to Leon Czolgosz, and a letter from Briggs regarding the donation of the collection to the John Crerar Library.
