**Abstract** Allison Dunham (J.D.'39 Columbia University) began teaching at the

University of Chicago Law School in 1951 as Arnold I. Shure Professor of Urban Law. Best known for his work on probate and property law, Dunham was also an expert in the field of urban studies and was appointed Director of the Center for Urban Studies at the University of Chicago in 1971. The Dunham Papers consist largely of research materials related to Dunham's work on the Land Planning and Development Code. Additionally, the collection includes a small general files series which houses some student

papers and several folders of miscellaneous research materials.

# **Biographical Note**

Allison Dunham (1914-1992) was born in Wessington Springs, South Dakota. He graduated from Yankton College in 1936 and completed his law degree at Columbia University in 1939. Upon graduation, Dunham spent two years clerking for Supreme Court Justice Harlan F. Stone. He then taught at Columbia University and Indiana University before joining the faculty of the University of Chicago Law School in 1951, where he remained until his retirement in 1983. While at the University of Chicago, he held several administrative positions: in 1971 he was appointed Director of the Center for Urban Studies and in 1976 he was named General Counsel of the University and Secretary of the Board of Trustees.

In addition to fulfilling his various roles at the University of Chicago, Dunham also worked with several public and private organizations in order to promote the standardization of American law. He worked on the Uniform Commercial Code, sat on the Illinois Commission on Uniform State Laws, and from 1962 to 1969 was the executive director of the National Conference of Commissioners on Uniform State Laws.

Dunham was an expert in probate and property law, including zoning, land regulation and urban development and published widely on these topics.

Dunham died at his home in 1992 in Pomona, California and was survived by his wife Anne Toll; his two sons, Stephen, of Denver, and Andrew, of Colorado Springs; two brothers, Douglas Dunham of East Lansing, and Roger Dunham of San Francisco; and two grandchildren.

# **Scope Note**

The Allison Dunham Papers contain 7.5 linear feet of material and roughly cover 1936-1976, though the bulk of the materials were generated in the 1960s. The collection consists primarily of research materials related to Dunham's work on land planning and development. Additionally, there is a series devoted to general files in which a small collection of miscellaneous papers are housed.

# **Series I: Land Planning and Development**

The first subseries consists of files pertaining to a larger project to create a land planning and development code. These files include correspondence, notes, and drafts of the code. The second subseries contains case-study files, the contents of which range from the development and use of agricultural land in the state of New York to the development of Chicago's Woodlawn neighborhood. Subseries III covers materials related to beautification specifically and consists largely of reports on and proposals for scenic developments. Subseries IV contains a wide variety of journals and other shorter publications whose contents relate to land planning and

development, while Subseries V consists of general files. Again, these files consist largely of reports and proposals.
