Abstract This collection contains the papers of Soia Mentschikoff, law professor at the University of Chicago, Dean of the Law School at the University of Miami, and one of the chief drafters of the Uniform Commercial Code. The collection includes correspondence, articles, legal documents, teaching materials, and drafts and revisions of the Code. Material in the collection dates from 1913-1987, with the bulk dating from 1950-1984.

Information on Use

Access

Series I-XII of the collection are open for research with no restriction; material in Series XIII is restricted for 50 or 80 years from the date of creation, except for student material, which is restricted for 80 years from the date of record creation or until the death of the student.

Biographical Note

Soia Mentschikoff was born April 5, 1915 in Moscow, to Russian-American parents Roman and Eugenia Mentschikoff. The family left Russia just before the 1917 Revolution, and Soia grew up in New York City. She entered Hunter College at age 15 and graduated with a BA in Political Science and English in 1934. She earned her LL.B. from Columbia Law School in 1937.

After law school, Mentschikoff went to work in New York City, specializing in labor and commercial law. She became a partner in 1944. In 1942, Mentschikoff was named Assistant Chief Reporter for the Uniform Commercial Code, where she worked closely with Chief Reporter (and her former professor) Karl Llewellyn.

In 1946, Mentschikoff and Llewellyn were married, and the following year they moved to Cambridge, Massachusetts, where Mentschikoff became the first woman to teach at Harvard Law School, three years before the School admitted female students. Four years later, Mentschikoff and Llewellyn received appointments at the University of Chicago Law School, where Mentschikoff was again the first female faculty member. In addition to teaching classes, she headed a project applying quantitative research methods to the study of arbitration decisions. Upon Llewellyn's death in 1962, Mentschikoff was promoted from Lecturer to Professor (the school's anti-nepotism policies prevented both members of the couple from holding the position at the same time).

Mentschikoff continued to be active in the drafting and ratification of the Uniform Commercial Code during the 1950s and 1960s and became a member of the Code's Permanent Editorial Board when it was formed in 1961.

In 1967, Mentschikoff began teaching at the University of Miami in addition to the University of Chicago. In 1974 she was named Dean of the University of Miami Law School. She taught and served as Dean at Miami until 1981.

Mentschikoff was a member of a number of professional organizations. Most notably, she served as President of the Association of American Law Schools in 1974, was a member of the Council of the National Endowment for the Humanities from 1965-1971, held various offices in the American Bar Association, and was on the Board of Trustees of the RAND Corporation. She was the author, with Irwin P. Stotzky, of *Theory and Craft of American Law: Elements* and editor of the casebook *Commercial Transactions: Cases and Materials*. In addition to her interest and expertise in commercial law, Mentschikoff was also interested in the study of decision-making (integrating sociological and legal research), arbitration, legal education, and international law.

Mentschikoff died June 18, 1984, in Coral Gables, Florida.

Scope Note

The collection contains correspondence, articles, legal documents, teaching materials, and drafts and revisions of the Uniform Commercial Code. Material in the collection dates from 1913 to 1987, with the bulk dating from 1950 to 1984. It is divided into 13 series.

Series I, Personal, contains personal papers and material related to Karl Llewellyn. Materials are arranged chronologically.

Series II, Correspondence, contains correspondence, arranged chronologically.

Series III, University of Chicago, contains material from Mentschikoff's time at the University of Chicago Law School. It is divided into two subseries, Teaching and Administrative.

Series IV, University of Miami, contains material from Mentschikoff's tenure as Dean of the University of Miami Law School. It is also divided into two subseries, Teaching and Administrative.

Series V, Research, contains both project material and research materials not clearly associated with a particular project. This includes miscellaneous case notes and summaries, briefs and opinions, and government and institutional reports not related to the UCC or URSA, arranged alphabetically by title, name of case, or name of study or project.

Series VI, Revised Uniform Sales Act, contains drafts of and comments on this piece of legislation. Material is arranged chronologically.

Series VII, Uniform Commercial Code, contains correspondence, drafts and revisions, comments, legal briefs, and articles pertaining to the Uniform Commercial Code. It is divided into 5 subseries: General, Articles of the Code, The Permanent Editorial Board, The Code and the States, and Writings about the Code.

Series VIII, Writings, contains essays, articles, casebook materials, and texts of talks and lectures written by Soia Mentschikoff, as well as material for untitled and unattributed books. It is divided into two subseries: Articles, Essays, and Talks, and Unknown Typescripts.

Series IX, Writings by Others, contains articles, journals, a few monographs, texts of public talks, and a master's thesis by persons other than Soia Mentschikoff. Material is arranged alphabetically by author.

Series X, Professional Activities and Organizations, contains correspondence, meeting minutes, reports, and other material from various organizations and professional activities, such as conferences and symposia, with which Mentschikoff was involved. Material is arranged by organization. The series is divided into three subseries: General, American Bar Association, and Association of American Law Schools.

Series XI, Audio-Visual, contains a number of unidentified Flexi-disc recordings and a small number of photographs, arranged alphabetically by subject.

Series XII, Oversize, contains oversize news clippings, a certificate, and a photograph, arranged chronologically.

Series XIII, Restricted, contains material restricted for 50-80 years from the date of creation.

Series VII: Uniform Commercial Code

This series contains material related to the Uniform Commercial Code. It is divided into 5 subseries.

Subseries 1, General, contains general correspondence about the Code, records of the National Conference of Commissioners on Uniform State Laws (one of the bodies primarily responsible for drafting the Code), drafts of the entire legislation with comments and amendments, and documents from a few court cases that cite the Code. Material is arranged chronologically.

Subseries 2, Articles of the Code, contains drafts, comments, correspondence and extensive reports about individual articles of the Code (material is arranged numerically by Article number and chronologically within each article). There is a good deal of material on Article 9 to be found in the States subseries as well, due to attempts to amend the Article in New York.

Subseries 3, Permanent Editorial Board, contains correspondence and memoranda, comments and recommendations, and other records of the board created to shepherd the UCC through ratification and amendment, and interpret it for judicial and other purposes. The subseries also contains several amicus curiae briefs filed by the Board, as well as other case materials from cases involving the UCC. Material from Board Subcommittees on multiple Articles is found here rather than in the Articles subseries. Board documents and reports related specifically to a single article of the Code are arranged by article in Subseries 2.

Subseries 4, The Code and the States, contains materials relating to the ratification and impact of the Code by individual states, as well as attempts to amend the Code. Materials are arranged alphabetically by state and then chronologically.

Subseries 5, Writings about the Code, contains articles and booklets about the Uniform Commercial Code, including guidelines for interpretation and pamphlets created for lobbying purposes. Material is arranged alphabetically by author (or title where author is not applicable).

Series X: Professional Activities and Organizations

Association was found with other AALS materials. It is included here. Almost all of the material dates from 1973-1974, and so is arranged alphabetically by committee name or subject.
